

In the Probate Court of Idaho County, State of Idaho,
 In the matter of the Estate of
 Benjamin F. Farris,
 Deceased. } Decree of Distribution

Paula Farris, Administratrix of the estate of Benjamin F. Farris, deceased, having on 24th May, 1916, filed in this Court his final account and petition for distribution of said estate, and setting forth that said estate is in a condition to be closed; that a portion of said estate remains to be divided among the heirs of said deceased; and praying that the residue be distributed to the parties entitled thereto; and said matter coming on regularly to be heard this June 5th, 1916, and it appearing to the satisfaction of the Court that due and legal notice of the time and place of said hearing has been given as required by law and the order of the Court; that the claims against said estate have been settled and the expenses of administration paid; that all taxes upon the property of said estate and all inheritance or transfer taxes have been paid; that the residue of said estate, consisting of the property hereinafter described, is now ready for distribution and that said estate is in a condition to be closed.

And it further appearing that the residue of said estate is community property; that the said Benjamin F. Farris died intestate, leaving surviving him the following named persons, to-wit:

Paula Farris his widow and Beatrice O. Farris, his daughter, his only heirs at law; that the residue of said property remaining on hand being community property, his said widow, Paula Farris, is entitled to the whole thereof.

It is ordered, adjudged and decreed, that the residue of said estate, hereinafter described, and any other property which may belong to said estate, or in which said estate may have any interest, be and the same hereby is distributed as follows, to-wit:


To Paula Farris, widow of decedent, the whole of the residue of said estate now remaining.
